### **5-2-1: DEFINITIONS:**

**OWNER:** Any person who owns, possesses, keeps, exercises control over, maintains, harbors, feeds, waters, transports, or sells an animal, or one who assists another in possession, sale, transport, harboring, feeding, watering or maintenance thereof. An owner need not have any pecuniary, proprietary or economic interest in a dog.

**CONFINED:** Keeping an animal within an enclosure that cannot be opened by any person other than the owner or with the owner's assistance or consent and from which an animal cannot escape.

**DANGEROUS DOG:** Any dog that:

- A. Without justified provocation has inflicted serious injury on a person while on public or private property;
- B. Has killed a domestic animal without provocation while on public or private property;
- C. Has been previously found to be a potentially dangerous dog where the owner has received notice of such determination and the animal subsequently meets the definition of a "potentially dangerous dog" for a second time within a six (6) month period.
- D. Has been kept with the intention of using its size, manner, disposition, training or breeding to instill fear in others; or
- E. Has been bred, trained, owned, possessed, or kept for the purpose of dogfighting.

### **5-2-4: DOG LICENSES:**

**A. License Required;** Exceptions: It shall be unlawful for any person to own, harbor, keep or possess a dog which is older than four (4) months of age within the city without first procuring a license as required by this chapter, except:

1. Dogs whose owners are nonresidents, temporarily within the city for thirty (30) days or less.
2. Dogs brought into the city for the purpose of participating in shows, exhibits, or competitions.
3. Dogs which are specially trained to assist visually impaired, hearing impaired or otherwise physically disabled persons, if the dog is in training or is actually serving as a guide or service dog.
4. Dogs kept and intended for sale by licensed pet stores.

### **5-2-5: LICENSE TAGS:**

**A. Tag To Be Worn:** Every owner shall be required to provide each dog, potentially dangerous dog or dangerous dog a collar or harness to which the license tag must be securely affixed, and shall ensure that the collar and the tag are constantly worn. A special license tag of such color and design that will allow clear and easy visual identification of the animal as a potentially dangerous or dangerous dog will be issued to the owner at the time the license is issued. This tag shall be worn at all times by the dog. Show dogs, during showing, are exempted from wearing the collar and tag.

**B. Lost Tag:** A replacement regular license tag shall be issued by the city clerk upon payment of the current fee as established by resolution of the council for each tag so issued to replace the original tag which was lost or destroyed. Replacement dangerous dog license tags shall be issued upon certification that the original tag was lost or destroyed and upon payment \$5.00 for each tag.

**C. Unlawful To Remove:** No person shall remove or cause to be removed the collar or tag from any licensed dog without consent of the owner, keeper or harbinger thereof. (Ord. 617, 12-12-2016)

### **5-2-8: OFFENSES AND CONDITIONS:**

**A. Dogs Running At Large:** It shall be unlawful for any owner, or the parents or the guardians of any such person under eighteen (18) years of age, to allow a dog(s) to run at large unless: 1) upon the private premises of another with the consent of the person in possession of such premises; or 2) such dog be under the direct and immediate care and control of a person and controlled by a leash not exceeding eight feet (8') in length; or 3) such dog be safely confined in a motor vehicle. No dog shall be left inside a vehicle when the temperature and/or humidity are high or when temperatures are near or below freezing. Dogs secured in the bed of a pickup or cargo area of any truck must be secured in such a manner as to prevent any part of their body from extending past the edge of the platform or bed.

**D. Habitual Barking Or Noisemaking:**

**1. Prohibition:** It shall be unlawful for any person to fail to exercise proper care and control of his animal that frequently, excessively, or untimely barks, yelps, howls, whines, cries or makes other noises that are audible off the owner's property. When none of the residents who reside at the place where the offending dog is being kept are at home at the time a dog is making such noises which give rise to a complaint, such absence shall create a rebuttable presumption that the dog's barking, howling, whining or yelping was unlawful.

**2. Impoundment:** Any such animal in violation of this section may be seized and impounded if such disturbance reoccurs after the person in control of the premises has received two (2) prior warnings or citations within a period of six (6) months from the animal control agency. It is not a defense that prior warnings or citations involved different animals.
