PROJECT TITLE: **SW 7<sup>TH</sup> Street, S Iowa Ave to S Pennsylvania Ave**

Separate sealed BIDS for construction of sidewalk improvements in Fruitland Idaho, as set forth in the Contract Documents for the **SW 7<sup>TH</sup> Street, S Iowa Ave to S Pennsylvania Ave** Project will be received by City of Fruitland at the City Hall, Office of the City Clerk, 200 S. Whitley Drive, Fruitland, Idaho 83619, until **2:00 p.m.** local time on **March 31, 2025** and then publicly opened and read aloud at said City Hall.

This project is funded in part by the Children Pedestrian Safety Program through LHTAC and **Buy America and Davis Bacon Wages are in effect for this project. All project requirements are based on the City Standards and the construction will be administered by the City of Fruitland.** The Contractor shall coordinate all work with the City Public Works Director. The work to be performed by the Contractor includes the construction of approximately 300 square yards of concrete sidewalk, 4 pedestrian ramps, 740 feet of curb and gutter, 111 square yards of concrete driveway approaches, 2 catch basins, 187 feet of storm drain pipe, sanitary sewer manhole replacement, precast sediment boxes, seepage beds, thermoplastic pavement markings, asphalt pavement patching, excavation, base course and other miscellaneous items of work. All parts or work not specifically mentioned which are necessary in order to provide a complete installation shall be included in the bid and shall conform to all City of Fruitland requirements.

Upon request, the Bidder shall submit such information as deemed necessary by the Owner to evaluate the Bidder's qualifications.

All bids must be signed and accompanied by evidence of authority to sign.

Bids must be accompanied by Bid Security in the form of a bid bond, certified check, cashiers check or cash in the amount of 5% of the amount of the bid proposal. Said bid security shall be forfeited to the City of Fruitland as liquidated damages should the successful bidder fail to enter into contract in accordance with their proposal as specified in the Instructions to Bidders.
