Notice is hereby given, in accordance with Idaho Code 63-1311A, of a public hearing to be held by the Fruitland City Council at Fruitland City Hall, 200 S. Whitley Drive, Fruitland, ID on February 27, 2023 at 7:00 P.M., or as soon thereafter as may be heard, to consider public comment regarding a proposal to amend current fees by adding new permitting fees for Door to Door Solicitors, Street Stand Merchants, Mobile Food Units, and Special Events. The purpose of the new fees is due to the restructuring of the permitting process expanding the type of permits, creating the need for new fees to cover the cost in labor and materials. Citizens are encouraged to provide written and oral testimony. The proposal may be reviewed at Fruitland City Hall during regular business hours, 8AM-5PM, Monday-Friday or online at www.fruitland.org.

The fees for door to door peddler/solicitors, street stand merchants, mobile food units, and special events are as follows:

- ~~Transient auctioneers or auctioneers holding non-reoccurring sales:~~ \$15 per day
- ~~Auctioneers holding regular auctions at a specified location:~~ \$100 per year
- ~~Itinerant merchants, peddlers, agents, independent contractors, solicitors:~~ \$15 per day
- ~~Circuses and carnivals:~~ \$200 per day
- ~~Side shows or performances, whether human, animal or non human:~~ \$25 per day
- ~~Street stands:~~ \$25 per day
- ~~Selling from motor vehicle or transportable platform:~~ \$25 per day
- ~~Businesses not specifically named herein, but operated on a less than a continuous bases, i.e. Christmas Trees, Seasonal Produce:~~ \$100 per year

- ~~Background check:~~ \$30.00 per applicant
(Split: \$20.00 Idaho State Police; \$10.00 City of Fruitland)

- Door to Door Peddler/Solicitor \$100.00 (12 months license)
- Mobile Food Unit \$100.00 (12 months license)
- Street Stand Merchant \$60.00 (6 months license)
- Special Events Permit \$100.00 per event (*Churches and schools are exempt from paying Special Event permit fee*)
- Special Events Cleaning Deposit \$500.00 per event
- Special Events Cleaning Fee \$30.00 per hour, 1 hour minimum
